3. FY 2020

President Geisler clarified that budgets shall be passed in the form of resolutions.

A. Maximum Allowable Taxes

Motion to accept the maximum allowable taxes under the Headlee Rollback Amendment.

B. Major Street Fund Transfers to Local Street Fund

Motion made by Nathan Anderson and seconded by Paulie Mihelcich to transfer up to 25% of Act 51 funds from the Major Street Fund to the Local Street Fund in FY 2020. President Geisler polled the Council: Yes: King, Harrer, Rowe, Dwyer, Mihelcich, Anderson, Geisler No: None Motion Carried

Motion made by Nathan Anderson and seconded by Paulie Mihelcich to lower the budget in the police section of the general village fund to \$100,000 that the village will no longer have two full time officers but will retain 1 full time officer and 1 part time officer. The village will notify Blake Frantti that the village will retain him as a part time employee and this part time position will be implemented over a period of 60 days. During that 60 days he will still retain the full accrual of sick time and stipend if any due to him. The reduction in hours will be 4 hours a week each week beginning the second week after the beginning of the next pay period until the amount of time equals 24 hours a week at which time the public safety and finance committees with recommend the amount of hours necessary to remain within that budget.

President David Geisler polled the Council: Yes: Anderson, Harrer, Geisler No: Dwyer, Rowe, King, Mihelcich Motion Defeated

A discussion was had regarding the above motion to reduce one police officer position to part time as a means to move toward a balanced budget. Concerns were expressed including public safety, fiscal responsibility, workload, and officer recruitment challenges for a part time position. Alternatives were presented including having the finance and other committees identify areas in the budget where reductions could be made, as well as seeking grant opportunities to supplement the budget, and potential reductions to the village administration budget.
