## III. Agenda

## 1. Old & New Business

- Trustee Anderson presented a draft Medical Marijuana (Marihuana) Facilities Ordinance.
- Trustee Anderson encouraged the council to move forward on the Zoning Board of Appeals Ordinance Restatement.

- Trustee Dwyer expressed concerns regarding the Village Treasurer's meeting attendance and records.

Motion made by Trustee Dwyer to communicate with the Village Treasurer regarding retrieving village records and determining their intentions. No Second. Motion Failed.

- A discussion was had regarding winter parking complaints and issues and ordinance enforcement.

Resolution presented by Trustee Dwyer and seconded by Roxanne King and reads as follows: This is a resolution affirming the need to clarify parking and snow issues within the Village of Calumet in conjunction with village winter parking regulations that are in effect yearly from November 15 through April 15 of the following calendar year. Where as the village affirms the need to convey all parking and snow issues to the village police department in conjunction with the village street department during the above time frame all snow and parking issues will be assessed by both departments to determine if any complaints or issues are deemed to be a public safety issue by police, street department or both. - Trustee Dwyer requested an update on the formal complaint she filed with President Geisler regarding the budget process. A discussion was had.

# 2. Petitions from the Public

Peggy Germain addressed the council, making the council aware of an article about municipal finance reform recently published in the Michigan Municipal League's official magazine, *The Review*, as well as continued concerns regarding the budget timeline.

Sandy Johnson addressed the council regarding winter parking. She thanked the street department for their efforts regarding snow removal, thanked the council for not cutting the police department, and encouraged the council to write into any Medical Marijuana Facility Ordinance that all costs related to registration, inspection, and regulation be the responsibility of the applicant/facility and that village tax dollars should not pay for it.

# 3. Public Safety (Police & Fire)

Trustee Anderson presented the Public Safety Report.

Motion made by Trustee Anderson and seconded by Trustee Harrer that the police department conduct village hall security checks twice a day when on duty, evening and early morning, and the internal door to the fire department stay unlocked until such a time as we have a better method of entry for the fire department.

Motion amended by Trustee Anderson and Trustee King to add to the original motion that the Elm Street Village Hall entrance remained locked at all times. President David Geisler conducted a voice vote: Yeas: All Nays: 0 Motion Carried 6/0

Motion made by Trustee Harrer and seconded by Trustee King to accept the safety committee and police department report. President David Geisler conducted a voice vote: Yeas: All Nays: 0 Motion Carried 6/0

# 4. Elm St. Infrastructure Project Update

Chris Holmes, Civil Engineer, U.P. Engineers and Architects provided an update on the Elm St. Infrastructure Project.

Motion made by Trustee Anderson and seconded by Trustee Harrer to receive and open bids for the Elm St. Infrastructure Project at the village hall on Thursday, April 25th at 1pm and it be open to the public. President David Geisler conducted a voice vote: Yeas: All Nays: 0 Motion Carried 6/0

President Geisler introduced the Public Participation Plan produced by WUPPDR, part of the Redevelopment Ready Communities.

A. Street, Sanitation, Public Buildings (Street Dept)

Trustee Harrer presented the street report:

- Spring clean potentially the first week of June.
- Renting out the pavillion. \$500 a month, \$500 deposit.
- Feasibility of rehabilitating the DPW garage/new location.
- Possibility of using sanitation budget to buy a dump trailer.
- Trash can locations
- Street Sweeping

Motion made by Trustee Anderson and seconded by Trustee King that the village advertise on the village website, Main Street Calumet website, and flyers on doors to rent the pavillion from May 1st to November 1st with a \$500 deposit, \$500 monthly rent and requiring appropriate insurance. A discussion was had regarding the cost effectiveness of purchasing a dump trailer, as well as, where it would be stored.

Clerk Weir presented the clerk's report:
