AN ORDINANCE GOVERNING THE DESIGN, CONSTRUCTION, ALTERATION, EN-LARGEMENT, EQUIPMENT, REPAIR, DEMOLITION, REMOVAL, CONVERSION, USE, OR MAINTENANCE OF ALL BUILDINGS AND STRUCTURES: KNOWN AS THE BUILDING CODE; PROVIDING FOR THE ISSUANCE OF PERMITS, COLLECTION OF FEES, MAKING OF INSPECTIONS; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; DECLARING AND ESTABLISHING FIRE LIMITS; AND REPEALING ALL OTHER ORDINANCES OR PARTS THEREOF IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CALUMET, STATE OF MICHIGAN, AS FOLIOUS:

SECTION 1. ADOPTION OF BUILDING CODE. That cartain documents, three (3) copies of which are on file in the office of the Village Clerk of the Village of Calumet, being marked and designated as the "Basic Building Code", 1965 Edition, as published by the Building Officials Conference of America, Luc., be and is hereby adopted as the building code of the Village of Calumet, in the State of Michigen; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions, and terms of the "Basic Building Code", 1965 Edition are hereby referred to, adopted and made a part hereof, as if fully set out in this ordinance.

SECTION 2. FIRE LIMITS ESTABLISHED. That the Fire Limits in the Village of Calumet as defined and described in the "Besic Building Code" are hereby established as follows:

The point of beginning is 660 feet West of the East one-quarter corner of Section 14 in Township 56 North of Range 33 West; thence North along the East boundary of the Village of Calumet a distance of 660 feet; thence West along the North boundary of aforementioned Village of Calumet, a distance of 1980 feet; thence Sputh along the West boundary of the aforementioned Village of Calumet, a distance of 2640 feet; thence East along the South boundary of the aforementioned Village of Calumet, a distance of 1396 feet; thence South 0° 26' West, a distance of 262.14 feet; thence South 55° 44' 30" East, a distance of 14.97 feet; thence South 63° 04' 30" East, a distance of 125.27 feet;

thence North 34° 16° East a distance of 645.93 feet; thence North 89° 35' 30" West a distance of 120.08 feet; thence North 0° 25' 30" East a distance of 80 feet; thence North 89° 35' 30" West a distance of 270 feet; thence North along the forementioned East boundary of the Village of Calumet a distance of 375 feet; thence East a distance of 81.0 feet; thence continuing North along the aforementioned East boundary of the Village of Calumet a distance of 125.0 feet; thence West a distance of 59.0 feet; thence continuing North along the East boundary of the eforementioned Village of Calumet a distance of 124.0 feet; thence West a distance of 22.0 feet; thence continuing North along the aforementioned East boundary of the Village of Calumet a distance of 401.0 feet; thence West a distance of 80.0 feet; thence continuing North along the eforementioned East boundary of the Village of Calumet a distance of 566.0 feet; thence East along the South boundary of the aforementioned Village of Calumet a distance of 574.0 feet; thence North along the aforementioned East boundary of the Village of Calumet a distance of 80.0 feet to the Foint of Reginning; Consisting of 101.36 acres, more or less, and located in the Township of Calumet, County of Houghton and State of Hichigan.

SECTION 3. INCONSISTENT ORDINANCES REPEALED. That all ordinances or parts of ordinances in conflict herewith are hereby repealed;

or in the Building Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquitted, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this Ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance;

SECTION 5. DATE OF EFFECT. That the Village Clerk shall certify to the adoption of this Ordinance and cause the same to be published as required by law; and this Ordinance shall take effect twenty (20) days after approval as so certified.
