ORDINANCE NO. 147

AN ORDINANCE REPEALING ORDINANCE NO. 86 REGULATING THE COLLECTION AND DISPOSITION OF GARBAGE, AND ORDINANCE NO. 128 PERTAINING TO THE COLLECTION AND DELIVERY OF SOLID WASTE WITHIN THE VILLAGE OF CALUMET

The Village of Calumet ordains that the following ordinances of the Village of Calumet are repealed:

SECTION 1 – Title

This Ordinance shall be known and may be cited as the Village of Calumet's Repealer of an Ordinance for the Regulating the Collection and Disposition of Garbage, and an Ordinance Pertaining to the Collection and Delivery of Solid Waste.

SECTION 2 – Intent and Purpose

The purpose of this Ordinance is to repeal the following ordinances of the Village of Calumet:

- A. Ordinance No. 86, adopted on September 8, 1956, for the collection and disposition of garbage.
- B. Ordinance No. 128, adopted on September 18, 1990, pertaining to the collections and delivery of solid waste within the Village of Calumet, and providing for the enforcement thereof and for other matters relative thereto.

These ordinances have been superseded by Ordinance No. 132, as amended and restated, regulating the collection, removal and disposal of garbage within the Village of Calumet.

SECTION 3 – Repeal

Ordinance No. 86 and Ordinance No. 128 of the Village of Calumet are hereby repealed in their entirety.

SECTION 4 – Effective Date

This amended Ordinance shall be effective after publication and expiration of the time thereafter prescribed by law but not earlier than May 31, 2018.
