a. Petitions from the Public

Peggy Germain addressed the council the sidewalk decision made by the council at the prior meeting. She warned about the precedent it could set in the village.

b. Loader Bid Discussion

Manager Katz gave updated the council on the search process, what types of machines have been located, and what options there are as far as front-end loaders. Manager Katz also gave details on the USDDA grant that we received and this bid process that

the Village needed to follow. Manager Katz also gave an overview of the finances that would accompany the loaders. He updated the council that all the loaders are in the \$65,000.00-\$67,000.00 range with shipping. The Village's match would be approximately \$23,000.00. The council had no additional questions.

DPW Superintendent Klein took the floor to give a summary of what he wanted in a machine, what he has seen so far as types of machines and the quality of those machines. He also reported on his review of the Case 821e in Chilton, WI. DPW Superintendent Klein was impressed with the machine, he has taken oil samples, and he gave specific details on the machine. He would be pleased with the machine and believes it would last a long time with our Village.

c. Sno Go Bid Discussion

Manager Katz another overview of finances and specifications on the Sno Go bid that was received from Macqueen Equipment. Superintendent Klein was asked by the council for his opinion on the condition and worthiness of the Sno Go. His opinion was that he is impressed with the machine, likes the quality, and believes it is one of the best he has seen for that price. He also thinks it is very sound and a great deal.

d. Purchase of Sno Go and Loader

Motion made by Trustee Abramson and seconded by Trustee King to buy the loader for \$66,200.00 with \$43,100.00 coming from the grant, and the Village will pay \$23,100.00 and the purchase of the Sno Go for \$65,000.00 with \$48,700.00 coming from the grant and the Village will pay \$16,300.00.
