ORDINANCE NO. 114

AN ORDINANCE INCREASING RATES AND CHARGES FOR THE USE AND SERVICE OF THE WATER SUPPLY SYSTEM OF THE VILLAGE OF CALUMET, COUNTY OF HOUGHTON, ADOPTING A LEASE, OPERATING AND WATER PURCHASE AGREEMENT BETWEEN THE VILLAGE OF CALUMET AND NORTHERN MICHIGAN WATER COMPANY AND OTHER MATTERS RELATING TO SAID SYSTEM.

WHEREAS, the Village of Calumet (the "Village") has leased the potable and fire protection water systems (the "Water System") of the Village to Northern Michigan Water Company (the "Company") in the past; and

WHEREAS, the Village and the Company desire to make a new Agreement for the lease and operation of the water systems of the Village for the purchase of water, and concerning the Water System of the Vilage and the sanitary sewage system and storm sewage system of the Village, this Agreement to be entitled "LEASE, OPERATING AND WATER PURCHASE AGREEMENT" and to be dated November 25, 1981; and

WHEREAS, it is necessary for the public health, safety and welfare for the Village to acquire and construct improvements to the Water System; and

WHEREAS, the cost of said improvements is presently estimated not to exceed \$321,000; and

WHEREAS, the Village expects to obtain grants in the amounts of \$75,000 from the Upper Great Lakes Regional Commission and \$25,000 from the Farmers Home Administration to pay part of said improvements; and

WHEREAS, The Village deems it necessary to borrow an amount not to exceed \$221,000 and to issue its revenue bonds therefor to pay part of the cost of said improvements; and

WHEREAS, payment of a principal of and interest on said revenue bonds as due requires an increase in the revenues of the Water System in an amount which is approximately twenty-eight percent (28%) greater than the estimated gross revenues of the Company in 1982;

NOW, THEREFORE, THE VILLAGE OF CALUMET ORDAINS:

- 1. The water rates and charges for the services supplied by the Village's Water System as set forth in Article II, paragraph 4 of the proposed LEASE, OPERATING AND WATER PURCHASE AGREEMENT, which rates and charges are to be collected by the Company as lessee of the Water System on behalf of the Village, shall be and are hereby increased by twenty-eight percent per annum. Said increase shall be collected by the Company on behalf of the Village for water provided to users commencing December 29, 1981, and shall be determined by increasing by twenty-eight percent (28%) the bimonthly billing to each customer based on the rates in effect at the time of such billing.
- 2. The proposed LEASE, OPERATING AND WATER PURCHASE AGREE-MENT shall be and is hereby approved and adopted, and the President and Village Clerk shall be and are hereby authorized and directed to execute said Agreement on behalf of the Village.
- 3. In the event that the Agreement is not renewed upon its expiration, the Village shall forthwith adopt a rate ordinance that will provide for the collection of revenues sufficient to pay the principal of and interest on the revenue bonds to be issued by the Village to pay part of the cost of the improvements to the Water System and to ensure the payment of expenses of administration, operation and maintenance as may be necessary to preserve the Water System in good repair and working order and for such other purposes as the Village may determine.
- 4. This Ordinance shall be published in full in the Copper Island Sentinel, a newspaper of general circulation in the Village, promptly after its adoption, and shall be recorded in the Ordinance Book of the Village and such recording authenticated by the signatures of the Village President and Village Clerk.

5. This Ordinance is hereby determined by the Village Council to be immediately necessary for the preservation of the peace, health and safety of the Village and is therefore declared to have immediate effect.
