ORDINANCE NO. 143

AN ORDINANCE TO FULFILL THE REQUIREMENTS OF 2004 PA 286-300 TO PROVIDE FOR THE TERM AND MANNER OF ELECTION OF GENERAL LAW VILLAGE OFFICERS AND TRUSTEES. THIS IS A RESTATEMENT OF AN ORDINANCE PREVIOUSLY ADOPTED BY THE VILAGE COUNCIL ON DECEMBER 21, 2004.

The village council of the Village of Calumet ordains:

Section 1. Three of the Village Trustees shall be elected at each biennial village election for the term of four years and until their successors are qualified. The president, clerk and treasurer of the village shall also be elected for terms of four years and until their successors are qualified. Elections of village officers and trustees shall occur in the month of November in even years contemporaneously with the regular November election conducted by the township clerk of the Township of Calumet.

Section 2. The next regular election for the Village of Calumet shall occur in November, 2010.

Section 3. The terms of the following incumbent officers and trustees shall be extended as follows:

a. The term of Anthony Bausano, Village President, is extended from September, 2011, to November, 2012.

- b. The term of Joyce Bausano, Village Clerk, is extended to November, 2010. Joyce Bausano was appointed to fill a vacancy in the office of village clerk. Consequently, she may hold office only until the next election of village officials. The next three elections for the position of village clerk shall occur in November, 2010, November, 2012, and November, 2014.
- c. The term of Debra Aubin, Village Treasurer, is extended from September, 2011, to November, 2012.
- d. The term of Joseph Mihal, trustee, is extended from September, 2011, to November, 2012.
- e. The term of Jane VanEvera, trustee, is extended from September, 2011, to November, 2012.
- f. The term of Abe Voelker, trustee, shall expire on November, 2010. Abe Voelker was appointed to fill a vacancy on the village council. Consequently, he may hold office only until the next election of village officials. The next election thereafter for this position as trustee on the village council shall occur in November, 2014.
- g. The term of Jonathan Pressel, trustee, shall expire on November, 2010. Jonathan Pressel was appointed to fill a vacancy on the village council. Consequently, he may hold office only until the next election of village officials. The next election thereafter for this position as trustee on the village council shall occur in November, 2014.
- h. The term of Paul Coon, trustee, shall expire on November, 2010. Paul Coon was appointed to fill a vacancy on the village council. Consequently, he may hold office only until
