F. Planning Commission Expectations: Review of Village Ordinance 94 from October 17, 2017

The Commission reviewed the entire current Planning Ordinance (#94). Per Section 2 of the ordinance, Membership, the Commission decided to document the diversity and interests of its current members.

<u>Commissioner Christopher Green</u>: retired mechanical engineer, resident of the Village, homeowner in the Village since 2000, Chairman of the Village's Historic District Commission

<u>Commissioner Andrew Ranville</u>: Commercial building owner, proprietor and resident in the Village's downtown district, elected member of Village Council, DDA member, actively involved in three non-profit organizations promoting natural resource preservation, participant in local Farmer's Market. Active in outdoor sports

<u>Commissioner Virginia Dwyer</u>: has lived in the same spot in the Village since 1970. She retired from the Houghton County Sherriff's Office, is a former Village of Calumet Trustee, and is a strong proponent of the Village's residential sector. She has been involved with the Swedetown Trails and ski club.

<u>Commissioner Pete Hahn</u>: has lived in the Copper Country for 44 years and currently resides in Calumet Township. He currently is a business owner in the Village and operates out of rented space. Recently he purchased a vacant building in the village, which he intends to restore and rehabilitate. He is an outdoors person and a volunteer.

<u>Commissioner Colleen Kobe</u>: has been a Copper Country resident since 2013 and currently is a Calumet Township resident, software engineer, and teacher with good writing and public speaking skills along with computer knowledge. She has completed MSU's 'Citizen Planner' class and as Planning Commission Chair since 2017, her desire is to see the Village thrive.
