Adjustments to the Budget from FY 2022

Verbal Review of the adjustments

General Fund:

General Government – Increased from \$100,000 to \$105,000 due to anticipated costs for audit, and general costs averages over the last few fiscal years.

Fire – Adjusted to purchase pagers \$1,400, total of \$29,400

DPW – Increased from \$145,000 to \$150,000 due to average cost over the last few years.

Theatre Maintenance Costs – Added this item to reflect the associated minor repair cost during the year.

Community and Economic Development – added this line item, this expenditure is for Planning and Zoning.
