4. Fire Site Redevelopment Update

Chair Polzein gave an update that the Fire Site Task Force will be meeting to review the 4 RFP's received for the Concept Design and will make a recommendation to the Council. Discussion on the public input session in April and the need for plans for Agassiz Park and the 4th Street Corridor. Signs from the National Park for the fire site should be up soon.

5. Heinonen Project Support

Chair Polzein discussed the DDA Budget including support for projects in the DDA district along with matching grant funds. Mr. Heinonen owns 205-207 5th Street and is working with an architect on plans for the building which would be funded by the MEDC and would require a local match. Request for \$5k earmarked for the project should it continue with MEDC support.

Trustee Ranville expressed concern over the project possibly changing the roof line of the historic building and not being within HDC Guidelines.

Discussion on the process of approving matching grant funds was had, including the request for Developers to first confirm the project with Village Zoning and obtain HDC approval, then present a plan to the DDA prior to the DDA earmarking the matching funds.
