An Ordinance adopted pursuant to 1969 PA 306, as amended, to adopt by reference the Uniform Traffic Code for Cities, Townships, and Village; and to repeal all conflicting ordinances or parts of ordinances.

THE VILLAGE OF CALUMET HOUGHTON COUNTY, MICHIGAN ORDAINS:

Section 1 – CODE AND AMENDMENTS AND REVISIONS ADOPTED

The Uniform Traffic Code for Cities, Townships, and Villages as promulgated by the director of the Michigan Department of State Police pursuant to the Administrative Procedures Act of 1969, 1969 PA 306, MCL 24.201 through 24.328, and made effective on October 30, 2002, and all future amendments and revisions to the Uniform Traffic Code when they are promulgated and effective in this state are incorporated by reference.

Section 2 – REFERENCE IN CODE

References in the Uniform Traffic Code for Cities, Townships, and Villages to a "governmental unit" shall mean the Village of Calumet.

Section 3 – NOTICE TO BE PUBLISHED

The Village Clerk shall publish this ordinance in the manner required by law and shall publish, at the same time, a notice stating the purpose of the Uniform Traffic Code for Cities, Township, and Villages and the fact that a complete copy of the code is available to the public at the office of the Village Clerk.

Section 4 – PENALTIES

The penalties provided by the Uniform Traffic Code for Cities, Townships, and Villages are adopted by reference.

Section 5 – REPEAL

Ordinance No. 117 of the Village of Calumet and all other ordinances or parts of ordinances which conflict with this ordinance are hereby repealed.

Section 6 – EFFECTIVE DATE

This Ordinance shall become effective 30 days after its publication, as required by law.
