AMENDMENT TO ORDINANCE NO. 115

AN AMENDMENT TO ORDINANCE NO. 115 TO REDUCE AN INCREASE IN WATER RATES FOR THE VILLAGE OF CALUMET, COUNTY OF HOUGHTON, PREVIOUSLY ESTABLISHED BY ORDINANCE NO. 115.

WHEREAS, a twenty-eight (28%) percent increase in the bi-monthly billings to each customer in the Village of Calumet was established by Ordinance No. 115 for the Village of Calumet; and

WHEREAS, there has been a general increase in the water rates for customers within the Village of Calumet as established by the Michigan Public Service Commission; and

WHEREAS, it is presently appropriate, because of the aforementioned increase in water rates established by the Michigan Public Service Commission, to decrease the increase or surcharge in water rates established by Ordinance No. 115;


NOW, THEREFORE, the Village of Calumet ordains and amends Paragraph 1 of Ordinance No. 115 of the Village Ordinance as follows:

"The water rates and charges for the services supplied by the Village's water system as set forth in Article 2, Paragraph 4 of a Lease, Operating and Water Purchase Agreement presently in effect between the Village of Calumet and Northern Michigan Water Company, which rates and charges are to be collected by the Company as Lessee of the Water System on behalf of the Village, shall be and hereby are determined to be twenty-five (25%) percent per annum of the water rates and charges established for Northern Michigan Water Company for the Village of Calumet by the Michigan Public Service Commission. This increase shall be collected by Northern Michigan Water Company on behalf of the Village for water provided to users commencing August 30, 1983, and shall be determined

by increasing by twenty-five (25%) percent the bi-monthly billings to each customer based on the rates in effect at the time of such billing."

This Ordinance shall be published in full in the Copper Island Sentinel, a newspaper of general circulation in the Village, promptly after its adoption, and shall be recorded in the Ordinance Book of the Village and such recording authenticated by the signatures of the Village President and Village Clerk. This Ordinance is hereby determined by the Village Council to be immediately necessary for the preservation of the peace, health and safety of the Village and is therefore determined to have immediate effect.


