ORDINANCE NO. 125

AN ORDINANCE TO AMEND ORDINANCE NO. 114 AND ORDINANCE NO. 115 OF THE ORDINANCES OF THE VILLAGE OF CALUMET AND TO DETERMINE THE AMOUNT OF A SURCHARGE ON THE RATES AND CHARGES FOR THE USE AND SERVICE OF THE WATER SUPPLY SYSTEM OF THE VILLAGE.

WHEREAS, it appears to the Village Council that a surcharge on the revenues of a water system as established in Ordinance No. 114 and as amended by Ordinance No. 115 is more than sufficient, at present, for the maintenance of a fund for maintenance and improvements to the water system of the Village Calumet and for debt retirement;

NOW, THEREFORE, the Village of Calumet ordains:

The water rates and charges for the services supplied by the Village's water system, which rates and charges are collected by the Northern Michigan Water Company as lessee of the water system on behalf of the Village, shall be that amount established by the Public Service Commission of the State of Michigan plus eleven (11%) percent of the amount so established. The surcharge on the amount established by the Public Service Commission for the State of Michigan, as defined in this ordinance, shall be collected by the Northern Michigan Water Company and paid to the Village in accordance with the existing lease, operating and water purchase agreement, dated June 1, 1982, between the Village and the Northern Michigan Water Company. This Ordinance adjusts the aforementioned surcharge which had previously been established by Ordinance No. 114 and Ordinance No. 115 as 28% of the rates established by the Public Service Commission of the State of Michigan.

This Ordinance shall be effective after publication and expiration of the time prescribed by law.

Adopted and approved by the Village Council of the Village of Calumet on the 19th day of March, 1985.
