During a General Election to be held on Tuesday, November 8, 2022, the Voters of the Village of Calumet will have the opportunity to decide the following question:

Shall Ordinance Number 157 of the Village of Calumet providing that the village clerk shall be chosen by nomination by the village president and appointment by a majority vote of the village council be approved as authorized by section 1(3), chapter II of the General Law Village Act (1895, PA 3, as amended)?

Read the Full Proposed Ordinance set forth below.

Ordinance for the Appointment of the Village Clerk No. 157

PLEASE TAKE NOTICE that any qualified elector of the above-mentioned township and village who is not already registered, may register to vote at the office of the Calumet Township Clerk; the office of the Houghton County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms may be

obtained at mi.gov/vote and mailed to Calumet Township. Voters who are already registered may update their registration at: www.expressSOS.com.

The last day to register in any manner other than in-person with the Calumet Township Clerk is **October 24, 2022**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following address (Please call for hours):

ORDINANCE NO. 157

**ORDINANCE FOR THE APPOINTMENT
OF THE VILLAGE CLERK**

AN ORDINANCE to provide for the appointment of the village clerk of the Village of Calumet.

THE VILLAGE OF CALUMET ORDAINS:

Section 1. ESTABLISHMENT OF THE OFFICE

As authorized by Section 1(3) of Chapter II of the General Law Village Act, Public Acts of Michigan of 1895 as amended, MCL 62.1(3), the village clerk shall be chosen by nomination by the village president and appointment by a majority vote of the village council.

Section 2. TERM OF OFFICE

The term of office shall be two years, beginning November 15 of each even year with the first full term of the village clerk commencing on November 15, 2022. A village clerk initially appointed under this ordinance shall serve from the date of appointment until November 15, 2022.

Section 4. EFFECTIVE DATE

This ordinance shall take effect 45 days after the date of its adoption, unless a petition signed by not less than ten percent of the registered electors of the village is filed with the acting village clerk or village office within such 45 days.

If a petition is filed within such period of time, this ordinance shall then take effect only upon its approval at the next general village or special village election held on the question of whether the ordinance shall be approved. Notice of the delayed effect of this ordinance and the right of petition under this section shall be published separately at the same time and in the same manner as the ordinance or a notice of the ordinance is published in a local newspaper of general circulation.

Section 5. ADOPTION

This ordinance shall be adopted by an affirmative vote of at least two-thirds of the members of the Village Council.

Section 6. PUBLICATION

The village clerk or acting village clerk shall certify to the adoption of this ordinance and cause the same to be published as required by law.




