# 4. Ordinance 127 and Ordinance 153 Progress

The Commissioners had a lengthy discussion of the buiffer zones to be adopted regarding the siting of marihuana businesses within the Village. Buffer zones in the ordinance are proposed around churches, schools, child care facilies, parks and rehabilitation facilities. Maps of the Village were prepared and presented by Chair Kobe and and Manager Kobe with 250 ft., 500 ft.

and 1,000 ft. buffer zones from the properties identified in the ordinance. There was discussion as to the most appropriate buffer zones in each instance and the areas that the various buffers would put "off limits" to marihuana businesses. There was discussion as to the point the buffer should be measured – the property line or the entry way. This point is to be determined. There was discussion as to Agassiz Field – the athletic field owned by CLK Schools. Should this be included as part of the school in defining buffer zones. No agreement was reached.

#### 5. New Business

Manager Katz indicated that the Baptist Church located on 6<sup>th</sup> Street planned to purchase and move to the vacant church at 8<sup>th</sup> and Elm.
