ORDINANCE NO.: 137

AN ORDINANCE TO PROHIBIT NUDITY IN THE VILLAGE OF CALUMET

The Village of Calumet ordains:

Section 1. No person shall engage in public nudity within the Village of Calumet. No person shall aid, abet, sponsor, promote or provide a place to conduct public nudity within the Village of Calumet.

Section 2. "Public nudity" means knowingly or intentionally displaying in a public place, or for payment or promise of payment by any person including, but not limited to, payment or promise of payment of an admission fee, any individual's genitals or anus with less than a fully opaque covering, or a female individual's breast with less than a fully opaque covering of the nipple and areola. Public nudity does not include any of the following:

- (1) A woman's breastfeeding of a baby whether or not the nipple or areola is exposed during or incidental to the feeding.
- (2) Material as defined in Section 2 of Act No. 343 of the Public Acts of 1984, being Section 752.362 of the Michigan Compiled Laws.
- (3) Sexually explicit visual material as defined in Section 3 of Act No. 33 of the Public Acts of 1978 being Section

722.673 of the Michigan Compiled Laws.

Section 3. Any person shall violate the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction shall be punished by a fine not exceeding \$500.00, or imprisonment not exceeding 90 days or both, in the discretion of the Court, together with the costs of prosecution and court costs.

Section 4. This Ordinance shall be effective 30 days after its passage and publication as required by law.
